## INSTRUCTIONS

1. Read the application carefully, print or type clearly, and be sure to complete all applicable sections. For assistance, you may contact the Office of Licensing and Permitting in Tallahassee at (850) 487-3122.
2. Only individuals can hold stone crab trap certificates. Transfers submitted reflecting the buyer as other than an individual will be denied. No individual may possess more than 1% of the total number of certificates in existence for the year.
3. **This form, a copy of a notarized bill of sale, and all fees due must be either hand-delivered to the Florida Fish and Wildlife Conservation Commission or sent by certified mail within 72 hours of being signed and notarized. See front of form for mailing address. The transferee and transferor should retain a copy for their records.**
4. Transfers will be accepted only from June 15 through midnight March 1.
5. Any outstanding trap certificate fees, license fees, surcharges or any other charges owed to the Commission by either party (buyer or seller) must be paid before a transfer will be approved.
6. Buyer must hold a current Saltwater Products License with Stone Crab and Restricted Species endorsements in order to receive trap certificates.
7. If the transfer is **not** to immediate family member, the number of trap certificates must be reduced.
8. A street address must be provided for delivery of the tags. **Delivery service companies will not deliver to a Post Office Box.**
9. The transfer type must be identified by choosing one of the following: Standard, Eligible Crew, Family, or Immediate Family Transfer.
10. If "Eligible Crew" type is chosen, proof must be provided.
11. If the transfer is to family or immediate family member, the buyer must identify his relationship to the seller and provide proof thereof.
12. The total number of trap certificates being transferred must be broken down by category. (See definitions below for A1, A2, B)
13. The price paid to the seller for each certificate type must be stated and cannot be less than the annual fee for each tag.
14. Payment must be made in the form of a Cashier's Check or Money Order made **payable to the FWC**. The buyer is held responsible for any transfer fees / surcharge fees owed.
15. The seller's and buyer's signatures must be notarized.
16. **The Surcharge is 25% of the certificate sales price or \$1 per certificate, whichever is greater.** If this is indicated incorrectly on the transfer form, the transfer will be returned to the buyer for correction and resubmission.
17. Tag Audit Numbers must be verified by the buyer and recorded in the bottom position of Section 1.
18. **Reduction Tag Audit Numbers must be recorded in the bottom of Section 1 and must be received by this office prior to the transfer being completed.**

## DEFINITIONS

**"A1 - Certificates"** - Certificates that were allotted to the original holder. (A one-time surcharge fee will be due if A1 certificates are transferred outside the seller's immediate family.)

**"A2 - Certificates"** - Certificates that have been transferred from the original holder to an immediate family member. (A one-time surcharge fee will be due if A2 certificates are transferred outside the seller's immediate family.)

**"B - Certificates"** - Certificates that have been transferred outside of the original holder's immediate family and the one-time surcharge fee has already been collected by the Commission.

**"Immediate Family"** - **Mother, Father, Sister, Brother, Spouse, Son, Daughter, Stepson, Stepdaughter, Stepfather, Stepmother, Half-Sister, Half-Brother, Son-in-Law or Daughter-in-Law of the individual certificate holder.**

**"Sales Price"** - Price paid per all certificates by tag type. NOTE: The price per certificate should not include the annual fee per certificate.

**"Surcharge"** - A1 and A2 certificates being transferred outside the immediate family will require a one-time surcharge fee in addition to the transfer fee of \$1.00 per certificate. The amount of surcharge must be 25% of the category sales price paid to the seller or \$1.00 per certificate, whichever is greater. Except the transfer fee shall be \$.50 per certificate for eligible crew. There shall be no transfer fee if the transfer is within the immediate family because of death or disability.

**"Transfer Period"** - The transfer period is from June 15 thru midnight March 1 of each year. Transfers postmarked after midnight March 1 will not be processed. If any application for the transfer of certificates containing errors is received by the Commission after February 15, the Commission will make a reasonable effort to obtain a completed application by March 1. However, if such efforts are not successful within that period, the Commission will deny the request to transfer certificates and return the applicable fees submitted to the applicant.

**"Trap Tag Number"** - Each tag representing a certificate has a trap tag number or audit number in the bottom-right-hand corner of the tag.

**"X" Number** - Your Stone Crab Endorsement number, as shown on your Commercial Saltwater Products License.
