## **RULES GOVERNING VENDORS/EXHIBITORS/DEMONSTRATORS**

1. The Florida Fish and Wildlife Conservation Commission reserves the right to deny participation to any Vendor, Exhibitor or Demonstrator whose merchandize, booth, exhibit or demonstration does not conform to the theme (Support Native Wildlife) of the Chinsegut Reptile and Amphibian Festival. All items for sale must have a wildlife or natural resources conservation theme.
2. The Vendors/Exhibitors/Demonstrators agrees to carry adequate liability and other appropriate forms of insurance.
3. On average the Chinsegut Reptile and Amphibian Festival attracts approximately 400—700 visitors, however, the Florida Fish and Wildlife Conservation Commission makes no warrantee, implicit or implied, as to the actual number of visitors who will attend.
4. Standard exhibit space is 10ft x 10ft. If larger exhibit space is required, please contact Kristin Wood at 352-754-6722.
5. Exhibit space is provided on a first-come first-served basis on the date that the Vendor/Exhibitor Form is received and approved by the Director of the Chinsegut Nature Center. Vendors/Exhibitors/Demonstrator must note all special requirements on this form
6. Vendors/Exhibitors/Demonstrator must provide their own tents, tables, stands, chairs, extension cords or any other necessary equipment. Limited equipment may be borrowed on a first-come, first-served basis. If the exhibit, booth or demonstration requires use of a 110 volt electrical outlet please contact Kristin Wood at 352-754-6722.
7. The Chinsegut Reptile and Amphibian Festival is an open-air event that is held rain or shine.
8. Food vendors will be responsible for all health-related inspections and permits if applicable.
9. No generators will be permitted during the Chinsegut Reptile and Amphibian Festival.
10. The Florida Fish and Wildlife Conservation Commission, its staff and volunteers, will not be responsible for theft, loss of merchandise or its value, damage or injury of any person or property as may be suffered by Vendors, Exhibitors or Demonstrators.
11. Vendors/Exhibitors/Demonstrators must clean up their display area at the end of the Festival.
12. Vendors/Exhibitors/Demonstrators will be able to set up in their pre-assigned locations between 7:30 and 8:30 a.m. All Vendor/Exhibitor/Demonstrators vehicles must be removed from the exhibit area by 8:30 a.m. Vendors/Exhibitors/Demonstrators are expected to remain open until the close of the Festival day and will not be allowed to bring their vehicles into the exhibit area until the close of activities at 4:00 p.m. A parking area will be designated for Vendors/Exhibitors.
